Treason in the White House

Segment One

Shooting In San Bernardino

Before I address the main subject I want to say a few things about the shooting in San Bernardino. Last Saturday we were receiving information that this shooting had Middle Eastern connections, but it was still too early to comment on it.

Today we know that the husband was an American citizen and his wife was born in Pakistan. She came here from Saudi Arabia. We know is that this was an Islamic attack. We also know that this was part of a bigger plot. There is no way that these two individuals were the only ones involved. This was not a lone wolf attack. This couple also had a bomb making factory in their home. They had go-pro cameras and filmed the attack.

We instinctively knew this was an Islamic terrorist attack, but it seemed that the government and the media wanted to make it something else. As more information came out we found that these two were Muslim fundamentalists, and had been so for years. They were not radical Muslims, they were true Muslims acting according to the dictates of Islam, following the clear teachings of the Qur'an and the example of their Prophet, Muhammad. They both pledged their allegiance to ISIS.

What Is The White House Doing?

We are hearing and seeing things from the White House and this administration, that we believe, as do others, are acts of treason. These are things that are aiding and abetting the enemy and lessening the security of Americans.

My concern is that this attack is the first of many. There is no way that these two put this together without outside help. This attack was at least an ISIS inspired attack on American soil. This is the largest terrorist attack since 9/11.

We want to focus on what this administration is doing. We are going as far as to say that this is treason at the White House. We are going to lay out our case for this.

President Obama's speech on Sunday night was only the third time he addressed the nation from the Oval Office in the 7 years he has been in office. At least in this speech he called this what it was, a terrorist attack, although he did avoid saying it was Islamic. There are a lot of things that went on in the background to get this press conference to happen.

He made it sound like those who are on the no-fly list are still able to buy a gun in America. My first thought was that if the government deems them a threat to our country, why would we allow them to buy guns? It is not a constitutional right to get on a plane. Obama wants to take away a constitutional right if you are on that no-fly list.

We want security, but we must be careful about throwing our rights away. When we allow government to do certain things, they can use that power on you. Right now we are putting this on extremists, but how do you define extremists? They might call us Christian extremists and put us on the no-fly list. This would allow them to take away our constitutional right to keep and bear arms.

I did some research and I have found that there are people on the no-fly list that shouldn't be there. They have gone through the channels to get their names removed. They have found that once you are on the no-fly list it is nearly impossible to get your name off. This is a violation of the 4th and 5th amendments that guarantee due process under the law.

We had 14 people gunned down in cold blood and 21 more wounded by Islamic terrorists, and this administration's response is to make it more difficult for law abiding citizens to exercise their 2nd amendment right to keep and bear arms. Now that the focus is on terrorism instead of workplace violence, this has become more difficult because we know that the terrorists will use knives, bombs, and anything else to carry out their jihadist attacks.

The response of the President to take away the right to buy guns from those on the no-fly list would not have helped in the San Bernardino attack. These two were not on the no-fly list.

The guns used in this attack were already illegal in California. It didn't stop them, did it? Gun restrictions only restrict those who obey the law. No gun law has ever stopped a criminal or a terrorist.

Here is the definition of treason from 18 U.S. Code 2381:

18 U.S. Code § 2381 - Treason

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.

When one is elected to office he puts his hand on the Bible and swears an oath of allegiance. If such a person levies war against the United States, adheres to the enemies of the United States, giving them aid and comfort, it is treason.

It is our intention to prove that this administration, particularly the White House, is not only adhering to the ideology of the enemy, it is protecting Islam, giving comfort to Islam, and giving cover for the Islamists. Secondly that they are actually allowing and levying a war against America, directly or indirectly, by not preventing these types of attacks or not allowing law enforcement to do their jobs. Thirdly, they are aiding and comforting those enemies within the United States or elsewhere.

The Evidence

Treason is a serious charge and we are not making this statement lightly. We feel compelled, as citizens looking at the evidence of what is unfolding, that we must inform our followers. We are repeating what happened in the 1930's and 40's. At that time the enemy was Hitler, today it is the ideology of Islam. The only difference this time is that the ideology has a god attached to it. That doesn't make it less evil.

Our leadership, from the top, is aiding and abetting this enemy. This is obvious to those of us who have been studying this for any length of time.

Let's start by laying out the back story. After the San Bernardino attack, as usual, this administration and the media tried to make this about gun control. Gun control didn't work because the guns used were

already illegal in California. The reason the bad guys are called bad guys is because they don't obey the laws.

The White House's narrative was gun control, not Islamic terrorism. Once the FBI established that this was an act of terrorism it apparently sent the White House into a tailspin. We have learned that Obama did not want to give this speech. The White House felt that the FBI had made them look like fools.

Many think that Valerie Jarrett actually runs the White House. She was very upset that the FBI went public with the fact that this was Islamic terrorism. Here is what [DC Whispers reported](#):

Once that was known, Mr. Obama's enthusiasm is said to have "waned considerably." And then when the L.A. FBI office went public with calling San Bernardino a terrorist attack, both Barack Obama and Valerie Jarrett went into "warpath mode."

Jarrett's displeasure was apparently first to make itself known. She was outraged the FBI had done so without first getting prior approval from her. Jarrett was said to be particularly concerned with the proximity of the FBI's terror designation and the president's quick words on calling for more gun control measures soon after the actual San Bernardino terror attack.

Remember what the narrative was. This was a gun control issue, not a terrorism issue.

In his speech, Obama made several references to ISIL instead of ISIS. This is significant because the word "levant" in ISIL means the region that includes Israel. Using this term indicates that the land of Israel belongs to the Muslims. I believe using this term indicates that this administration is standing with the Palestinians against Israel.

There was a press conference give by the FBI Director, James Comey, sitting next to Loretta Lynch. He looked very uncomfortable. He gave the speech that was approved by the White House, and after the speech he took questions. The network killed the feed and there were no questions on air. The point is that the Obama administration is upset with the FBI for pointing out that this was an Islamic terrorist attack. That is the job of the FBI. It is their job to investigate this kind of attack and keep this nation safe. The reason the FBI is handling the San Bernardino investigation is because terrorism is a federal crime. If it was not terrorism it would be handled by local officials.

One thing we do know is that, for this administration, this was supposed to be a gun issue, not a terrorism issue, and it did get them upset when it was announced that it was terrorism.

Obama is losing credibility with the American people. Polls show that the majority of Americans think that his handling of the terrorism issue has been poor.

How many people have to die before Obama will handle this in a truthful manner? He is putting people like us at risk in this nation.

You cannot fight an enemy unless you define who your enemy is. Our war is not with terrorism. Terrorism is a tactic, not an enemy. It is a tactic used by Islam to fight against us. Segment Three

One of the things that disturbed me the most is what Loretta Lynch, the Attorney General, said after the attack. She was scheduled to go speak at a Muslim Advocates anniversary dinner where she was to stand up for Muslims. Rather than denouncing acts of terrorism, she said that the [Justice Department is prepared to take “aggressive action”](#) against people employing anti-Muslim rhetoric that “edges towards violence.”

Let me remind you, we still have a First Amendment that protects freedom of speech. This includes our right to share information like what we are sharing with you. Fortress of Faith is about exposing Islam for what it really is. Many would see this as anti-Islamic rhetoric.

Speaking at Muslim Advocate’s 10th anniversary dinner, Lynch said since the terrorist attacks in Paris last month, she is increasingly concerned with the “incredibly disturbing rise of anti-Muslim rhetoric ... that fear is my greatest fear.”

Think about that! Her greatest fear is not Islamic terrorism, it is anti-Muslim rhetoric? She also said:

“When we talk about the First amendment we [must] make it clear that actions predicated on violent talk are not American. They are not who we are, they are not what we do, and they will be prosecuted.”

Note that she used the word “prosecute.” This means that she will go after, and criminally charge, anyone she deems to be using anti-Muslim rhetoric that “edges toward violence.” Who determines what edges toward violence? This is a serious concern. The Justice department uses vague language into which they can plug any meaning they want. Notice that they say “edges toward violence,” not “calls for or encourages violence.”

The neighbor of Syed Farook saw things that were suspicious, but she was afraid to speak out because she didn't want to be called a racist or and islamophobe. This is exactly what the Attorney General is forcing people to do. Don't say anything because you may be prosecuted.

She has had to walk this back. She now says “we prosecute actions, not speech.” This does, nevertheless, show the attitude of this administration toward Islam. Remember, Obama continually

tries to separate ISIL from Islam. What does the first I stand for? It stands for Islamic. His support for what Loretta Lynch said is seen in a statement he made in a speech in 2009.

My responsibility as President of the United States is to fight against negative stereotypes of Islam wherever they appear.

What was Obama's campaign promise in 2008? It was that he was going to fundamentally change America. Sadly, we didn't ask what fundamentals he was going to change.

Remember, Islam means submission or surrender. In Islamic states you don't have the freedom to choose, the freedom to speak, the freedom to determine who governs you, how you worship and who you worship. The only freedom you have is to submit to Islam. This is one of the reasons they hate America.

For Islam to advance freedom has to be destroyed. When Obama supports and defends an enemy who wants to destroy our freedoms, he becomes an enemy of our constitution. This is the same constitution he swore to protect from enemies foreign or domestic.

The fact that Islam is the enemy of the freedoms given us by our constitution is easy to prove. If he advocates for this ideology that is trying to destroy us, it makes him an enemy of the constitution.

Last Monday night, December 7, 2015, the Director of Homeland Security, Jeh Johnson, was scheduled to speak at the Adams Center. Adams stands for All Dulles Muslim Society. It is headed by Imam Mohamed Magid. He is the outgoing president of ISNA. All of these are tied to the Muslim Brotherhood, which is tied to Hamas and is seditious to our government, our laws, and our nation. There is ample evidence of this going back to the Holy Land Foundation trial and the explanatory memorandum that was discovered from the Muslim Brotherhood which shows they want to overthrow America.

John Guandolo, on [Understanding the Threat](#) shows the ties of the Adams Center to the Muslim Brotherhood.

This memorandum is their play book. It is clear from what it says that their goal is to overthrow America, even using our own hands. This evidence is put into the record at the trial. The groups involved with carrying out the mission are listed. They include groups like ISNA, headed by Mohamed Magid, and the head of Homeland Security goes, 4 days after the attack in San Bernardino, to address the Adams center also headed by him. According John Guandolo, and we agree with them, this is an act of treason. This is aiding and abetting the enemy who is levying war against us.

I want you to know who John Guandolo is. He wrote the first counter-terrorism course for the FBI. When Obama came in, he threw out people like John Guandolo and others who clearly teach that you have to look at the source, in this case Islam, to understand why they are doing what they are doing.

In addition, Obama had all references to Islam or Islamic terrorism removed from law enforcement training materials. This is treasonous because it protects an enemy who is levying war against us.

Segment Four

We don't use the term "treason" lightly. We gave you the official definition earlier. We are basing what we say on the legal definition of treason and what we see coming from our government.

We have not seen credible evidence that the Muslim Brotherhood has renounced its decades-long commitment to non-violence.

The United States does not condone political violence of any kind and we continue to press actors of all viewpoints to peacefully engage in the political process. The United States is committed to thwarting terrorist groups that pose a threat to U.S. interests and those of our partners.

We have to ask: what planet are they on? What drug are they taking? The Muslim Brotherhood was founded in 1928 and worked with the Nazis in WWII. It is anti-Semitic to the core. It killed Anwar Sadat in Egypt. It kills Coptic Christians. This is the Muslim Brotherhood has a decades-long commitment to non-violence?

Even countries like the United Arab Emirates and Egypt, which are Muslim countries, have declared CAIR and other Muslim Brotherhood front groups as terrorist organizations. CAIR was an unindicted co-conspirator in the Holy Land Trail.
